GENERAL UPDATE

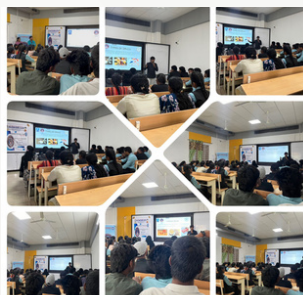
- We maintain an active presence on social media, with 47 posts, and consistently update our website to provide relevant information.

- 9 social media posts were published on our official handles under the guidance of Shri Srikanth.

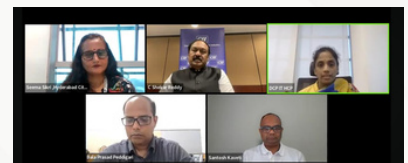


CSR FORUM

WOMEN'S FORUM

- 1st August: Shri Najamuddin and Smt. Sofia conducted a session on "Good Touch, Bad Touch" at Azaan School.

- Social media: 9 posts were published on our official handles under the guidance of Shri Rajasekhar Reddy.



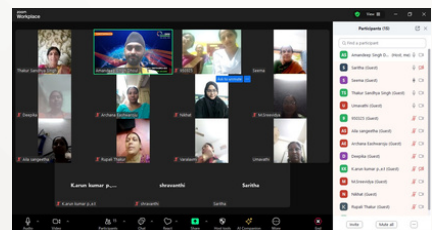
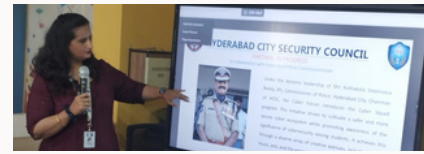
PHYSICAL SECURITY FORUM
