### WOMEN'S FORUM

**STREE** : The name reflects the vision - "She Triumphs through Respect, Equality and Empowerment, in short "STREE". The program intends to empower the women at grassroot level. The basic support system available for women in distress, the redressal mechanisms in place and the law of the land to empower, protect them are being spread through awareness sessions.







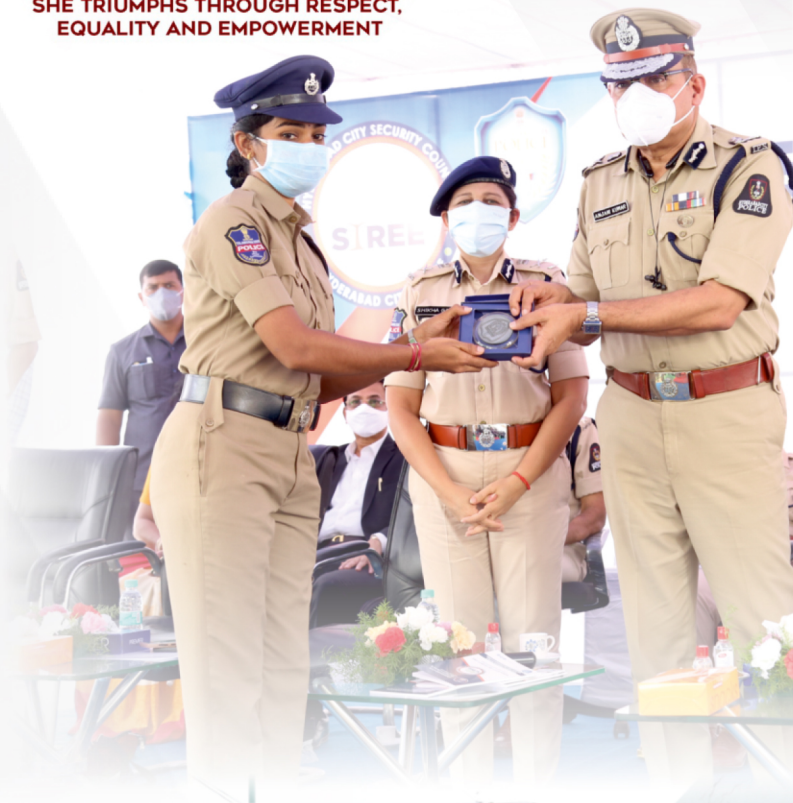
## Launch of the STREE Counselling centre

To enable the volunteers to conduct the counselling and also undergo training we decided to launch the Counselling centre at the Old Golconda PS on 1st July 2021.

Post which most of the cases are being dealt with there. Cases are being received at the Center daily since the launch (01 Jul 2021). A total of 135 cases have come for counselling and 130 are successful and 5 are pending cases.

- ▶ We have a total of 65 volunteers in the Asif Nagar division.
- ▶ We have completed around 25 training sessions both physical and virtual for the volunteers.
- ▶ Expansion of STREE program to North zone and South zone – Planning to launch in North zone.
- ▶ Gender Sensitization to Cab & Auto drivers– every Thursday. We have oriented close to 600 auto drives at 15 transport junctions.
- ▶ Sessions to children from classes 1 to 10 on good touch and bad touch have begun in October, we have completed around 15 schools and reached a target of over 1000 students
- ▶ We have oriented around 400 plus women police recruits at the CPTC on women Safety. We will like to thank our Addl. Commissioner Law and Order D.S Chauhan Sir for this opportunity.





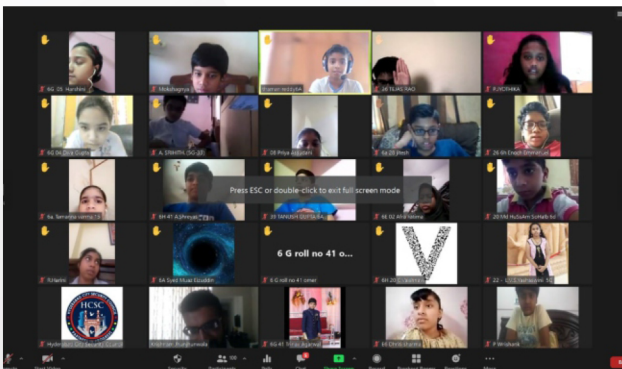

## TRAFFIC FORUM

**WeCoP** – Virtual awareness sessions have begun and are ongoing (Around 12000 students from 50 schools have been covered so far)



**WeCoP Rules**

- School children while travelling on motor bike with their parents to and from school, must wear helmet and it is Mandatory by the Motor Vehicles Act. Helmets save injury and our brain remains safe. All pillion riders must wear helmets.






**Traffic Farishtey** (Traffic Volunteers) new batches trained in August 2021 and November 2021. We have completed manning 22 junctions with 120 volunteers.

- » Basic Life Support.
- » Basic Traffic Training.
- » Traffic Awareness.
- » A real time experience of managing traffic at junctions.
- » Addressing First aid.
- » Reacting in case of an accident

An app to report any violations, count work hours of the volunteers, select the junction of his / her choice to work is in testing phase and will be made available for volunteers soon.

Traffic awareness & gender sensitization sessions for auto and cab drivers has begun post lockdown, every Thursday – combined activity with Women Forum. We have oriented close to 600 auto drives at 15 transport junctions.











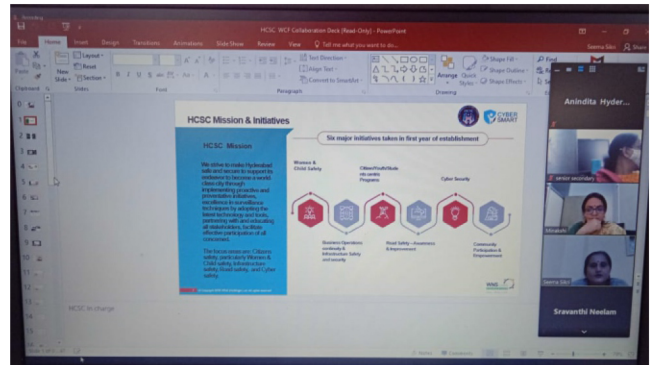
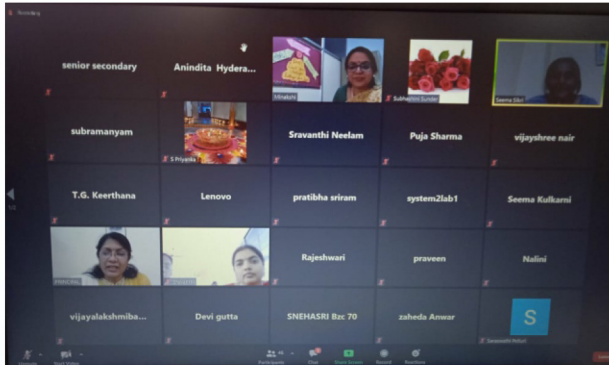
**Driver Sensitization Program :** We will be sensitizing / educating cab/bus drivers on traffic rules and regulations. During these sessions, the drivers are explained about the important role they play for the growth of Hyderabad city, how they are brand ambassadors of the city, how they should conduct themselves and stick to the safety protocols of safe driving, good behaviour towards passengers, more so towards women passengers and also the utmost importance of following traffic rules. As decided on various parameters like zero complaints from employees, on time adherence, zero accidents etc the drivers will also be rewarded.





## CYBER SECURITY FORUM

**Cyber Smart Program (Schools)** – 25000 students from 100 schools have completed the training (85% of school strength). Future programs in other zones along with computer teacher training. Felicitation of schools who took part in the CyberSmart program was conducted on 30th December 2021.
